# Fire Officer I, II, or III Certification Examinations

## Purpose

To allow firefighters who meet the necessary prerequisites to challenge a nationally recognized examination for the purpose of being certified under the National Board on Fire Service Professional Qualifications.

## Audience

Any fire department/company member who meets the general prerequisites as specified.

## Content

The written examination for Fire Officer I, II, & III certification consists of multiple-choice questions. Fire Officer I, II, & III tests are 100 multiple-choice questions. Test questions are based on NFPA 1021-2015 Standard for Fire Officer I, II, & III, also IFSTA “**Fire and Emergency Services Company Officer**”, 5<sup>th</sup> Edition for Fire Officer I & II, and IFSTA “**Fire and Emergency Services Chief Officer**”, 3<sup>rd</sup> Edition for Fire Officer III. In addition, applicants will be required to complete a practical applications package (assignment) to be submitted with the written exam.

## Practical Application (assignments)

Unless candidates have taken and passed, DSFS **Fire Officer I or II** course (respectively) within the last 24 months, each applicant testing for Fire Officer I & II will be given an assignment package before arriving at the written exam. The package includes practical applications required to be completed prior to leaving the test site.

Candidates applying to take the **Fire Officer III** test **MUST** have completed the DSFS Fire Officer III course assignments in their entirety within the last 24 months. **Challenging skills is not currently available.**

***NOTE: Applicants will receive a confirmation by mail or email upon acceptance. Applicant must bring a copy of the confirmation email and photo ID on test day to be admitted.***

- Application signed by the Fire Chief
